APPLICATIONS

Anywhere an interruption of power will cause a safety issue. Because it makes disconnection impossible, the Quick-Lock serves as a safety device, warning the operator to disconnect the power before removing. Requires a tool for removal or a key when used in conjunction with the Quick-Lock lock.

ENVIRONMENTS

The NFPA Publication 70-NEC and CEC define three categories of hazardous materials that have been designated as Class I, II or III. The Classes define the type of explosive or ignitable substances which are present in the atmosphere. Each of these Classes are divided into two Divisions. The Division defines the likelihood of the hazardous materials being present in a flammable concentration.

Class I = locations are those in which flammable vapors and gases may be present

Division 2 = In which ignitable concentrations of hazards are handled, processed or used, but which are normally in closed containers or closed systems from which they can only escape through accidental rupture or breakdown of such containers or systems.

Group Definition – the explosive characteristics of the air mixtures of gases, vapors or dusts vary with the specific material involved. Materials have been placed in Groups based on their ignition temperatures and explosion pressures. These Groups define substances by rating their flammable nature in relation to other known substances. Combustible & Flammable gases are divided into 4 Groups:

- Group A = Acetylene
- Group B = Hydrogen, Butadiene, Ethylene Oxide, Propylene Oxide
- Group C = Ethylene, Cyclopropane, Ethyl Ether
- **Group D** = Propane, Acetone, Ammonia, Benzene, Butane, Ethanol, Gasoline, Methanol, Natural Gas

The Quick-Lock is not UL rated for Class II or Class III or for Division 1 Hazardous Locations:

- Class II = locations are those in which combustible dust may be found
- Class III = locations are those which are hazardous because of the presence
 of easily ignitable fibers.
- Division 1 = In which ignitable concentrations of hazards exists under normal operation conditions and/or where hazard is caused by frequent maintenance or repair work or frequent equipment failure.

In the sample part number above, **CL23E02F006HL** is a mini "A" size cord set, double ended, 3 pole, male straight to female straight, using 16 AWG 3 conductor Super-Trex® cable (#8719C) and is six feet long. This cord set includes the Quick-Lock Assembly and is rated for Hazardous Location Class I, Division 2.
